

Terms and Conditions

These Website Terms and Conditions describe the terms under which you may make use of our website www.wiztoss.com (the "Website"), whether as a guest or a registered user. Please read this agreement carefully before you start to use the Website. By using our Website, you indicate that you accept these Website Terms of Use and that you agree to abide by them. If you do not agree to these Website Terms of Use, please refrain from using our Website.

Our services

There are two components to our website – registered user area and guest area. Registered users are granted unrestricted access to services which allows the member to request an online transfer of moneys and view this information at any time. Guests are given limited access to information tabs such as the process of online transfer of moneys, how to register, FAQs.

Exchange rates

HOJU JOBS PTY LTD may change the applicable exchange rate at any time to its own discretion. The exchange rate will be updated regularly and the customer will be notified of the current rate that will be applied to their transaction through the front page of the Website and on the second tab of the 'My accounts page'.

Fees

HOJU JOBS PTY LTD charges a fee on every payment unless indicated otherwise. Fees relating to each payment are visible to the user before submitting the payment.

Privacy Statement

Personal information collected by HOJU JOBS PTY LTD is treated as confidential and is protected by the Privacy Act (Cth) 1988. HOJU JOBS PTY LTD will only collect personal information which is necessary to perform the services contemplated by this Agreement.

Eligibility

To be eligible for our Services, you must be at least 18 years old. You further represent and warrant to us that if you are an individual and you open an Account with us that you are not acting on behalf of an undisclosed principal or a third party beneficiary.

Before being able to use the Service we have to perform mandatory customer verification. For that we may ask for photographic evidence of your identity such as a copy of your passport. It is possible to provide this evidence through a number of methods including email and Kakaotalk.

HOJU JOBS PTY LTD reserves the right to access various government and private databases so as to verify your information (so called "electronic ID") If certain databases provide a match to the information you provide then we may not have to ask for photographic evidence of your identity.

HOJU JOBS PTY LTD reserves the right to refuse to accept any new user or any transaction at its discretion.

Confidentiality of Client Information

- HOJU JOBS PTY LTD will use reasonable precautions to maintain the confidentiality of information HOJU JOBS PTY LTD receives from the Client and material and/or data the Client provides, creates, inputs or develops in connection with the Client's use of the HOJU JOBS PTY LTD Services. Nonetheless, because such information, material and/or data may be provided through the Internet or by facsimile transmission, the Client hereby acknowledges and agrees that HOJU JOBS PTY LTD cannot assure that such information, material and/or data will continue to be confidential.
- The Client accepts the risk of a third party receiving confidential information concerning the Client and specifically releases and indemnifies HOJU JOBS PTY LTD from any claim arising out of a third party intercepting, accessing, monitoring or receiving any communication from a Client intended to be provided to HOJU JOBS PTY LTD or from HOJU JOBS PTY LTD intended to be provided to the Client.
- The Client acknowledges and agrees that HOJU JOBS PTY LTD may disclose the Client's name and other personal and financial information about the Client, and any relevant details of an Authorised User, to its employees, representatives, officers, agents, and affiliates, as well as to a governmental entity or self-regulatory authority, an Internet service provider or any other third party agent or service provider for any purpose related to offering, providing, administering or maintaining the HOJU JOBS PTY LTD Services, or to comply with applicable Laws.
- HOJU JOBS PTY LTD will treat the Client's personal information in accordance with its privacy policy, which the Client may obtain by contacting HOJU JOBS PTY LTD or on the HOJU JOBS PTY LTD Website.

Anti-Money Laundering

- Due to the inherent risks in transferring currency between parties located in different countries, HOJU JOBS PTY LTD takes extraordinary measures to ensure that it is not participating or assisting in money laundering or terrorist financing. Law enforcement agencies and regulatory authorities may periodically inspect and require copies of Client information and business records held by HOJU JOBS PTY LTD, to ensure compliance with all applicable anti-money laundering and counter terrorism financing laws.
- The Client should be fully aware that in appropriate cases all communications and information concerning the Client held by HOJU JOBS PTY LTD, may be disclosed to and reviewed by law enforcement agencies and regulatory authorities. In addition, the Client agrees to comply with all applicable anti-money laundering and counter terrorism financing laws, including, but not limited to, the requirement to obtain satisfactory evidence of the identity of any principal whom the Client may represent in any transaction entered into with HOJU JOBS PTY LTD.

Limitation of liability

- HOJU JOBS PTY LTD will use all reasonable endeavours to make payments to the Client or to any third party specified by the Client, in accordance with the timing specified in the Client's Instructions. However, HOJU JOBS PTY LTD shall not be liable under any

circumstances for any direct, indirect or consequential loss (including any loss of profits) incurred as a result of a delay in funds reaching the Client's nominated account.

- HOJU JOBS PTY LTD will not be liable if a payee/beneficiary bank fails to process the Payment correctly.
- HOJU JOBS PTY LTD is not responsible for any delays, charges or loss incurred due to errors in the payment or beneficiary information supplied by the Client or where the Client has failed or delayed confirming the details of the Korean account using the functions integrated into the website. The Client agrees to indemnify HOJU JOBS PTY LTD and be liable for any losses or charges incurred by HOJU JOBS PTY LTD arising from such error on the Client's behalf.
- Nothing in this Agreement is intended to limit or exclude any liability HOJU JOBS PTY LTD may owe the Client under any statutory rights the Client may have.

Termination

- This Agreement may be terminated immediately by the Client or HOJU JOBS PTY LTD by Notice to the other in writing. However, termination by either party shall not affect any Order or other transaction previously entered into and shall not relieve either party of any outstanding obligations arising out of this Agreement, nor shall it relieve the Client of any obligations arising out of any Order entered into prior to such termination.
- In the event that HOJU JOBS PTY LTD is made aware of or has reason to believe any of the following:
 - (i) that the Client has provided false or misleading information to HOJU JOBS PTY LTD; or
 - (ii) that the Client has participated or is participating or has assisted or is assisting in money laundering or terrorist financing; or
 - (iii) that the Client is being officially investigated by law enforcement and/or regulatory agencies;

HOJU JOBS PTY LTD, at its sole discretion, may terminate this Agreement immediately by Notice to the Client, and HOJU JOBS PTY LTD shall be relieved of any obligations set out in this Agreement or arising out of the transactions contemplated by this Agreement, including any obligations arising out of any Order already placed with HOJU JOBS PTY LTD.

- Within two (2) Days of termination of this Agreement the Client will return or destroy all materials received from HOJU JOBS PTY LTD as per HOJU JOBS PTY LTD's written instructions. Each party's duties of payment, delivery, and destruction of materials shall survive termination of this Agreement. Any obligation of HOJU JOBS PTY LTD arising by operation of this clause is subject to HOJU JOBS PTY LTD's determination under this clause.
